6. Community Transport Scheme

7. Delegated Authority

At the meeting of the Parish Council held on 5th May 2021, it was resolved that:

- in accordance with Section 101 of the Local Government Act 1972, authority be delegated to the Clerk or in the absence of the Clerk, the Assistant Clerk, to make decisions on behalf of the Council where such decision cannot be reasonably deferred and must be made in order to comply with a commercial or statutory deadline, or the provision of ongoing Council services and business;
- 2) such decisions to be carried out where possible in consultation with the Chairman and Vice Chairman by electronic means, or telephone;
- 3) any decisions made under this delegation shall be noted at the next meeting of the Council:
- the delegation does not extend to matters expressly reserved to the council in legislation or in its Standing Orders or Financial Regulations and,
- 5) the resolution made by the Council on 15th April 2020, in relation to matters arising from the COVID-19 pandemic, whereby the Clerk, in consultation with **both** the Chairman and Vice Chairman of the Council, be delegated authority to authorise expenditure on behalf of the Council, which in the Clerk's judgement, it is necessary to carry out,

whether or not there is any budgetary provision for the expenditure, with such expenditure being subject to a limit of £2,000.00. and being reported to the council as soon as practicable thereafter, be reconfirmed.

The Council is requested to consider revoking the delegated authority as set out above, as it is no longer required.
